Proposed Action Title: Lease Extension at 314 Mill Street, Lead, South Dakota (LB-CX-23-03)

Program or Field Office: Berkeley Site Office, Lawrence Berkeley National Laboratory (LBNL)

Location(s): 314 Mill Street, Lead, South Dakota

Proposed Action Description:

Lawrence Berkeley National Laboratory (LBNL or Berkeley Lab) proposes to extend the existing lease of the residential premises located at 314 Mill Street, Lead, South Dakota, from approximately January 2024 until approximately December 2028, with the possibility of extending or renewing the lease as needed at a later date.

The purpose of this lease is to house Berkeley Lab-affiliated scientific and technical staff from the Sanford Underground Research Facility (SURF) operations office and from the Large Underground Xenon/MAJORANA Demonstrator (LUX/MJD) experiments office during their stay in South Dakota.


To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
