On behalf of my constituents, I am writing to express our unequivocal support for Lake Charles Exports, LLC's new application for long-term authorization to export LNG to non-Free Trade Agreement countries, and request for expedited consideration, from the existing Lake Charles Terminal. It is vital for the economic well-being of the state of Louisiana, my district and the country as a whole that the Department of Energy approve Lake Charles Exports application as soon as possible.

This project will have a significant positive impact on job creation and economic output for the state of Louisiana over the multiple year construction period.
