

Proposed Action Title: Recycling of DOE Excess Assets

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC covers the recycling of DOE assets for profit, including but not limited to electronics, scrap metal, brass casings, lead and lead acid batteries, and toner cartridges. These recycling services are provided via a subcontract between Savannah Rivers Nuclear Solutions (SRNS) and various subcontractors to SRNS. Asset Management & Distribution Operations (AM&DO) oversees these excess assets and subcontracts.

 \square The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
