<u>Proposed Action Title</u>: FGB Innovation, LLC -- Develop a Miniaturized NMR Sensor to Achieve Real-time Composition Measurement for Crude Oil Blending Application

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Newton, Massachusetts

Proposed Action Description:

Funding will support the project's small-scale research and development of a miniaturized nuclear magnetic resonance (NMR) sensor to measure the molecular structures of crude oil and enable more efficient blending of multiple oil sources. Specifically, the project team will (1) develop an analytical model through measurement of data from numerous crude oil sources, and (2) apply the NMR measurements of crude oils to identify composition of sources and improve the efficiency of refining processes. If successful, this project would enable oil refineries to more effectively blend a wider range of domestic and imported crude oil, thereby reducing the import of crude oil and the volume of crude oil required for refining usable fossil fuels.

Project activities will be conducted at an existing facility at FGB Innovation, LLC (Newton, MA). Project tasks fit within the class of actions identified under the DOE Categorical Exclusions identified below. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
