<u>Proposed Action Title</u>: Range Extenders for Electric Aviation with Low Carbon and High Efficiency (REEACH) Phase 2 (DE-FOA-0002240 and DE-FOA-0002241)

### **Proposed Action Description:**

The REEACH Phase 2 Program seeks to develop a disruptive system to convert the chemical energy contained in energy-dense carbon neutral liquid fuels (CNLFs) into electric power for aircraft propulsion via electric powertrains and other key systems. REEACH teams will build upon their Phase I systems to further develop innovative, cost-effective, and high-performance energy storage and power generation (ESPG) sub-systems. If successful, REEACH teams components and sub-system architectures will enable sufficient power to propel a fully electric, narrow-body aircraft through all the various flight phases and store sufficient energy to power the entire aircraft during a long-range mission with adequate safety reserves, reducing fossil fuel combustion and CO2 emissions.

The REEACH Phase 2 Program is composed of 5 small-scale research and development projects that will be conducted by universities, non-profit, and for-profit entities. This First Amended Determination adds 2 projects (University of Maryland and GE Research) to the Determination signed on September 12, 2020 (see Attachment for all 4 projects covered by this and the prior Determination). These projects fit within the class of actions identified under the DOE Categorical Exclusions identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the projects. This assessment was based on a review of the proposed scope of work and the potential environmental impacts of each project. All project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and Local regulatory requirements.
