

Proposed Action Title: Electrochemical Hydrogen Isotope Separation

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Fuel-cell style membranes will be used to evaluate hydrogen isotope separations. Hydrogen/deuterium (pure or mixtures) will flow on one side of the cell and nitrogen (humid or dry) will flow on the other side. Hydrogen isotopes will be pumped through a graphene layer to the nitrogen sweep gas. The gas will be analyzed via mass spectrometer, and the remainder will be oxidized for analysis in a water isotope water analyzer.
