

Proposed Action Title: Effect of Bacterial Activity of Vapor Corrosion Inhibitor Effectiveness

Proposed Action Description:

The proposed work will involve studying effectiveness of VCIs (Vapor Corrosion Inhibitors) in the presence of bacterial activity Rev. 1 adds measurement of corrosion causing bacterial activity in soil samples. Rev.2 extends the activity.
