

Proposed Action Title: New K-Area Complex (KAC) Commodity Center Warehouse, Two Buildings Option

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

A new "commodities center" warehouse (and parking area) will be installed in K-Area in support of the K-Interim Surveillance (KIS), Surplus Plutonium Disposition (SPD), and Criticality Control Overpack (CCO) Pad Facility missions. This center will help ensure that the storage function, along with processing preparations of materials needed, are brought closer to these missions, therefore minimizing potential processing impacts and increasing processing efficiency and throughput.
