Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Purdue University to design, develop, model, fabricate and test a novel rooftop heat pump for cold climates.

Design work, modeling, surveying, analysis, and lab testing would occur within pre-existing, purpose-built research and development facilities at Purdue University (West Lafayette, IN), Oak Ridge National Laboratory (Oak Ridge, TN), Copeland Corporation (Sidney, OH), and Trane Technologies (La Crosse, WI). Field testing would occur at a select industrial facility, replacing the existing rooftop air conditioning system with the prototype heat pump. The prototype would be connected to the existing duct work. No physical modifications to existing facilities, change to facility mission, or ground disturbance would be required.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

Minimal air emissions may occur as a result of laboratory work and testing. However, all emissions are anticipated to be negligible and would be within the limits of existing air permits at each facility. Award activities would involve handling of hazardous materials, such as refrigerants and solvents. Handling, storage, and disposal of hazardous materials would occur within controlled settings and would follow existing policies and procedures. Existing university, governmental, and corporate health, safety, and environmental policies and procedures would be followed at all facilities, including personnel training, proper personal protective equipment (PPE), engineering controls, monitoring, and internal assessments. Project activities would occur entirely at existing, purpose-built facilities; therefore, no adverse impacts to sensitive resources are expected as a result of the proposed activities.
