Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Guardian Devices, LLC for the design, development, assembly, and testing of photovoltaic (PV) connectors. Field testing would be carried out at existing solar facilities near Albuquerque, NM.

Proposed project activities would include stakeholder engagement, a pre-bankability study, design failure mode and effects analysis, cost model development, 3-D printing of polymers, metal part modeling and manufacturing, and assembly of prototype connectors. Testing would include arc-fault performance, evaluation and validation of connectors using the Highly Accelerated Lifecycle Test, and finally field testing. Field testing would involve the installation of PV connectors in outdoor field-testing arrays, using a 750 volt (V) residential grid and 1500 V utility grid.

A previous NEPA Determination (ND) was completed for all project activities (GFO-0010469-001; CX A9, B1.7; 04/25/23). This NEPA Determination covers proposed changes in project location and the addition of a new project advisor. Littelfuse, Inc. (Champaign, IL) would replace Amphenol Industrial Operations (Endwell, NY) for the purposes of in-lab test sequences. Additionally, a materials scientist in Mexico would advise on a portion of the project activities.

All other locations from the previous ND would still be participating. Office work would take place at Guardian Devices (Albuquerque, NM). Manufacturing would take place at Vamco Manufacturing (Albuquerque, NM) and assembly would take place at Guardian Devices. Field testing would take place at Public Utility Company of New Mexico (Albuquerque, NM), Sandia National Laboratory (Albuquerque, NM), and Emera Technologies (Albuquerque, NM). These sites are previously disturbed, and connectors would be installed in place of existing connectors, so no ground disturbance would take place.

The facilities at which project work would occur were designed for the type of activities being proposed; therefore, no adverse impacts to sensitive resources are expected as a result of project activities at any location. No change in the use, mission or operation of existing facilities would arise out of this effort. No modifications or new permits, additional licenses and/or authorizations would be required.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

DOE has determined that work to be carried out outside of the United States, its territories and possessions is exempt from further review pursuant to Section 5.1.1 of the DOE Final Guidelines for Implementation of Executive Order 12114; "Environmental Effects Abroad of Major Federal Actions."

The proposed action is categorically excluded from further NEPA review.
