Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Channing Street Copper Company (CSCC) to develop Energy Storage Equipped (ESE) appliances with in-appliance batteries, software, and Energy Storage Enabled Network (ESEN) capabilities in order to reduce costs associated with higher voltage ESEN appliances.

Award activities including planning, modeling, lab testing, data analyses, engineering, and prototyping would be carried out by CSCC (Berkeley, CA) in pre-existing laboratory facilities. Facilities may require some reconfiguration in order to accommodate the assembly and testing of ESEN appliances.

This award would be carried out in three budget periods (BPs). This NEPA Determination (ND) includes all of Budget Periods (BP) 1 and 2. All tasks in BP3 are dependent on developing pilot planning and site identification that would be carried out in Task 6 of BP2. As such, the potential impacts of BP3 activities cannot be reviewed at this time, and additional NEPA review would be required in the future.

The proposed award activities in BP1 and BP2 would consist of modeling, hardware prototyping and testing, software development, hardware-in-the-loop testing, certification planning, and pilot planning which would be carried out in an industrial location. Potential health and safety hazards would be present due to the nature of the award activities, including electrical shocks, fire hazards, and chemical exposure. Hazards would be mitigated by following existing safety protocols and regulations, following proper waste management procedures, and conducting regular safety inspections.

DOE has considered potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources.
