Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

B3.6 Small-scale research and development, laboratory operations, and pilot projects Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Research Foundation for SUNY on behalf of the University at Buffalo for monitoring a wastewater treatment system, computer modeling, and sample collection and analysis. Project activities would include information gathering, analysis, and laboratory operations.

Award recipients would monitor and experiment with the process controls of the EcoRecover system, an algal wastewater treatment and cultivation system, at the Village of Roberts (WI) Wastewater Treatment Plant. An alternate EcoRecover system at the Waupun (WI) Wastewater Treatment Plant would also possibly be utilized. Small samples of biomass (0.5-2 grams) would be harvested and shipped to laboratories at the University at Buffalo (Buffalo, NY) and Georgia Institute of Technology (Atlanta, GA) for characterization, sequencing, and analysis. The University of Illinois at Urbana-Champaign (Urbana, IL) would contribute computer modeling and computational analysis.

All project activities would be completed in existing, purpose-built facilities. No facility modifications, new permits, or licenses would be needed to perform project activities. Handling, storage, and disposal of hazardous materials would occur within controlled settings and would follow existing policies and procedures. Award recipients would adhere to established health and safety policies and procedures when performing project work, and would observe all applicable federal, state, and local health, safety, and environmental regulations.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
