Proposed Action Title: Eagle Butte Substation - Stage 03

Program or Field Office: South Dakota

Location(s) (City/County/State): Ziebach County, SD

Proposed Action Description:

This project is to add a 115kV ring bus or a 115kV breaker and half to the Eagle Butte Substation.

The project consists of replacing the single bus with a 115kV ring bus, thus replacing all of the 115kV equipment and the existing box structure. A new control building will be constructed. New control panels, relays, and communication termination equipment will be installed. The transformer, microwave tower, and 69kV facilities will remain in their current location, but all of the cables and accessories between the control building and the microwave tower will be replaced.

The project will expand outside the current fence. Additional land to the west of the substation may need to be purchased. The Eagle Butte Substation was built in 1962.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
