Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Association of Fish and Wildlife Agencies (AFWA) to support the participation of state fish and wildlife agencies throughout an industry-led process to develop nation-wide solar energy guidelines aimed at mitigating the impact of large-scale solar development on wildlife and natural habitats.

Activities associated with the proposed project would include documenting, summarizing, and communicating the needs and priorities of member agencies as they relate to the guidelines under development. AFWA would disseminate the results of the guideline development by creating a strategic information sharing plan, hosting webinars, and making digital media announcements. The proposed project would also focus on providing financial, logistical, and technical support (e.g., arranging travel, coordinating efforts, providing scientific expertise) to state agency representatives participating in the solar energy guideline discussions.

The proposed project would be limited exclusively to intellectual, academic, and analytical activities. AFWA would conduct project work at their offices in Washington, DC. Based on the types of activities proposed, DOE does not anticipate any impacts to resources of concern.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
