Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the University of Alaska Fairbanks to develop validated models of marine energy converters spanning several simulation platforms and time scales. The goal of the project is to create computer-based frameworks to enhance and use existing marine and hydrokinetic (MHK) simulation, models, and field data to develop power system simulation models for microgrid project sizing and design, energy balance, dispatch and planning, and power system stability studies. These frameworks would accelerate the acceptance of MHK energy devices into the microgrid and electric utility industry. Data would be collected and processed from marine resource datasets, including from existing marine and hydrokinetic (MHK) energy devices and the Wave Energy Converter Simulator, and used to generate power system models.

Proposed project activities include building of a generator-motor test platform, lab testing of the generator at various motor operating points and collecting voltage and current data using an oscilloscope. Project work would be performed at existing, purpose-built facilities operated by University of Alaska Fairbanks. Project work would be completed under the University's standard laboratory health and safety trainings and practices, which are mandatory for all personnel conducting testing in the lab.

No modifications to existing facilities, ground disturbing activities, or changes to the use, mission, or operation of existing facilities would be required. No additional permits, licenses, or authorizations would be required. DOE does not anticipate any impacts to resources of concern due to the proposed award activities.
