

Proposed Action Title: Chloride-Based Volatility of Uranium

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

To assess the effectiveness of the chloride-based volatility (CBV) process will be evaluated using mixed oxide (MOX) fuel. The process will have been previously validated using non-radioactive simulants. The UO2 in the fuel will be reacted in a test vessel with a chlorinating agent to form UCl4, which will volatilize away from the other actinides in the fuel. The UCl4 will be condensed and collected in a different section of the test vessel. Off-gas byproducts will be scrubbed from the off-gas stream.
