## Proposed Action Description:

Savannah River National Lab will perform experiments for the development of uranium chalcogenide and transition metal chalcogenide crystal grow with rad samples. The crystals grown in this lab will be done through flux growth in a crucible sealed inside a quartz ampule and heated in a muffle furnace. The project will be located in 735-A, labs A-146, A-148, and A-150.
