Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

CATEGORICAL EXCLUSION APPENDIX, NUMBER, AND DESCRIPTION: A9 Information gathering,

**analysis, and dissemination:** Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

**Rationale for Determination:** OCED is proposing to provide funding to Entergy Services, LLC in support of the Lake Charles Power Station Integrated CO2 Capture Project. The proposed project is the completion of a front-end engineering design (FEED) study of the installation of an amine-based CO2 capture technology which would capture CO2 from the flue gas at Entergy's existing natural gas combined cycle facility in Westlake, Louisiana. The study would include the design of a CO2 transportation pipeline and design of a CO2 injection well. The scope of this project would include project management; development of a community benefits plan; and design of a carbon capture, transport, and storage plan. Site characterization studies would consist of analyzing existing data that would be used to inform cost estimates and the engineering design. No lab activities, construction, or fieldwork would be performed.

Consultations (Section 106 NHPA, Section 7 ESA, etc): None required.

⊠ The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B (5) of 10 CFR Part 1021, Subpart D, Appendix B.

⊠There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal. The proposed action has not been segmented to meet the definition of a categorical exclusion.

⊠ This proposal is not connected to other actions with potentially significant impacts (40 CFR 1501.9(e)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.1(g)(3)) and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

⊠DOE has determined that work to be carried out outside of the United States, its territories and possessions is exempt from further review pursuant to Section 5.1.1 of the DOE Final Guidelines for Implementation of Executive Order 12114; "Environmental Effects Abroad of Major Federal Actions."
