Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

CATEGORICAL EXCLUSION APPENDIX, NUMBER, AND DESCRIPTION: A.9. Information Gathering, Analysis, and Dissemination: Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring.

**Rationale for Determination:** OCED is proposing to provide funding to Westinghouse (Recipient) in support of its PTES Project. WEC's planned activities for Phase 1 include final site selection, planning, and desktop analysis for the project.

Consultations (Section 106 NHPA, Section 7 ESA, etc.): None required.
