Sabine Pass Liquefaction, LLC and Sabine Pass Liquefaction Stage V, LLC hereby submit for filing this Application to the Office of Fossil Energy and Carbon Management of the DOE for long-term, multi-contract authority, as well as related short-term authority to export additional domestically produced liquefied natural gas ("LNG") from the Sabine Pass liquefied natural gas ("LNG") facility in Cameron Parish, Louisiana. The additional export authorizations requested in this Application relate to the liquefaction facilities proposed in the Sabine Pass Stage 5 Expansion Project ("Stage 5 Project") to be added to the existing SPLNG Terminal.

On this day, Sabine Pass Liquefaction, LLC and Sabine Pass Liquefaction Stage V have also filed Applications for Sections 3 and 7(c) of the Natural Gas Act ("NGA") with the Federal Energy Regulatory Commission to site, construct, and operate the Sabine Pass Stage 5 Expansion Project. A docket has not yet been assigned, but I will provide as a follow up once issued.
