Proposed Action Title: Solvent Extraction Testing - Radiological and non-radiological work

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC is based on approved EEC TC-A-2011-0068 "Solvent Extraction Testing in Radiological Confinements". This evaluation covers operation of miniature mixer-settlers and centrifugal contactors used for solvent extraction in 773-A laboratories C-102, C-077, C-135/139, and C-162. Solvent Extraction studies are performed to demonstrate the ability to separate desired actinides such as U or Pu from other impurities for eventual recovery and reuse. Complementary experiments without radiological components will be completed in labs in 735-A 142 laboratory 142 and 735-11A laboratories 142, 131, 129, 141.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
