Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

B3.6 Small-scale research and development, laboratory operations, and pilot projects Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Palo Alto Research Center (PARC) for the design, development, fabrication, and testing of manufacturing cost and carbon-intensity affordable ceramic matrix composite for the molten slag heat exchanger with supercritical CO2. Fabrication and development would occur at PARC, in Palo Alto, California. The design would occur at Temple University in Philadelphia, PA; the testing would occur at PARC and at the University of Wisconsin-Madison, Madison, WI; and the conversion of carbon fiber would occur at Advanced Ceramic Fibers, LLC, in Idaho Falls, ID.

Existing university and private industry health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments. Air emissions would result from laboratory research, but laboratory work would be performed under laboratory hoods and would fall under existing permits. PARC would obtain and comply with all required local, state and federal permits and regulations. Hazardous waste would be disposed and managed by Advanced Chemical Transport (ACT Environmental), a licensed hazardous waste hauler.

All project work would be performed at existing, purpose-built laboratory facilities. No modifications to existing facilities, ground disturbing activities, or changes to the use, mission, or operation of existing facilities would be required. DOE does not anticipate any impacts to resources of concern due to the proposed award activities.
