Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the University of Tennessee to develop highly active hexagonal boron nitride catalysts for the dehydrogenation of liquid organic hydrogen carriers.

Award activities would consist of catalyst preparation, preliminary structural and surface property characterization, and initial performance assessment. Award activities would be conducted in lab facilities at the University of Tennessee, in Knoxville, TN and Oak Ridge National Lab (ORNL) in Oak Ridge, TN.

Proposed activities would occur entirely within existing research and development facilities that are purpose-built for the type and scale of activities being proposed; therefore, no adverse impacts to sensitive resources are expected as a result of the proposed activities at any location. No change in the use, mission, or operation of existing facilities would arise out of this effort.

Award activities would involve handling and use of hazardous materials, including inorganic salts and aqueous solutions. Project activities involving hazardous materials pose no risk to the public. Hazardous materials would be utilized, managed, stored, and disposed of in accordance with applicable federal, state, and local environmental regulation. Existing lab, and governmental health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
