Description:

Rationale for determination:

The U.S. Department of Energy (DOE) Office of Energy Efficiency and Renewable Energy (EERE) Building Technologies Office (BTO) is proposing to issue a Funding Opportunity Announcement (FOA) (DE-FOA-0003225) for advancing building energy codes and building efficiency policies. Awards made under this FOA will be funded, in whole or part, with funds appropriated by the Infrastructure Investment and Jobs Act, more commonly known as the Bipartisan Infrastructure Law (BIL). Areas of interest would include state and local code adoption, high impact states and local jurisdictions, rural communities, tribal governments, workforce development, implementation and compliance, innovative approaches, utility and data and partnerships, equity, energy, environmental justice, and partnerships.

All selected awards would be limited to activities of an intellectual, academic, or analytical nature. Anticipated award activities would include but are not limited to building energy code education, training, outreach, and technical assistance. Each award would be expected to write a final report to disseminate project findings.

Participating entities would be identified as part of award selection processes. As such, award recipients and locations are not yet known. Despite this, further NEPA review would not be required for activities of selected awards under this FOA provided that all activities are consistent with the activity descriptions in this NEPA Determination.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

NEPA PROVISION

DOE has made a final NEPA determination.

This NEPA Determination applies to the issuance of the FOA as well as all awards selected under the FOA, provided the scope of the selected awards remains consistent with the intent of the FOA, as issued. If selected applicants

propose to use project funds for activities outside the scope of this NEPA Determination, additional NEPA review will be required.

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
