Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the Bethlehem Redevelopment Association to construct and install a roof-top solar photovoltaic (PV) array at the Historic Colonial Theatre (Theatre) in Bethlehem, NH.

The proposed project activities would include the following:

1) Some updates would be carried out on the existing asphalt shingled roof in preparation for the rooftop solar PV array. This would include shingling the peak of the roof, repairing the flashing and seams of the roof, removing an old exhaust vent, and patching the vent area.

2) The 37.2kW rooftop solar PV array and microinverters would be installed at the Historic Colonial Theatre located at 2050 Main St, Bethlehem, NH 03574. The array would be comprised of 93 400-watt modules and 93 microinverters and would provide electricity to the Theatre.

3) An electrical system would be installed to connect the array and the building to the local utility's electrical grid.

Ground disturbing activities would be limited to equipment and vehicle storage on the Theatre site and at an adjacent 600 square foot parking lot. All local building and electrical codes would be followed, as well as Occupational Safety and Health Administration regulations.

The Theatre has been identified as eligible for the National Register of Historic Places. Constructed in 1915, the Theatre operated on-and-off until it was renovated in 2001. Pursuant to Section 106 of the National Historic Preservation Act, DOE submitted a Request for Review to the New Hampshire Division of Historical Resources State Historic Preservation Officer and received concurrence with the determination that proposed project activities would have no adverse effect to historic properties. DOE also conducted a review of potential issues related to other resources of concern and found no effects that would be expected to result from the proposed project activities.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
