Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Bat Conservation International (BCI) to conduct analyses, investigate, and test the efficacy of Aviation Detection Lighting System (ADLS) for reducing bat fatalities at wind energy facilities.

The proposed activities for this award are separated into eight tasks spanning two Budget Periods (BPs) with a Go/No-Go (GNG) Decision Point in between. This NEPA Determination (ND) only applies to Task 0 and BP1. These activities must be completed to obtain sufficient information which is necessary to conduct a meaningful review of the remaining activities, i.e., BP2. If the project passes the GNG Decision Point, then an additional NEPA review must occur in order to continue into BP2. Activities under Task 0 and BP1 would include those of an analytical, intellectual, and academic nature, including desktop analyses of bat fatality rates with and without ADLS, project management, design activities, field site coordination, preparation for field activities, and developing Diversity, Equity, Inclusion, and Accessibility training. These activities would be carried out by BCI (Duluth, MN), the National Renewable Energy Laboratory (Golden, CO), and DeTect, Inc. (Panama City, FL).

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
