Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to General Electric (GE) Research to develop a High-Voltage Direct Current (HVDC) multi-terminal research model for wind energy applications.

The proposed project would include the design and development of controls and protection for HVDC networks and implementing them on a software-in-the-loop platform. The design and development of software models would occur at GE Research, Niskayuna, NY; National Renewable Energy Lab (NREL), Golden, CO; Virginia Tech, Arlington, VA; and The University of Texas at San Antonio, San Antonio, TX. The computer platform would be built at NREL.

Proposed activities would occur entirely within existing research and development facilities that are purpose-built for the type and scale of activities being proposed; therefore, no adverse impacts to sensitive resources are expected as a result of the proposed activities at any location. No change in the use, mission, or operation of existing facilities would arise out of this effort.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.
