Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. A11 Technical advice and assistance to organizations

Technical advice and planning assistance to international, national, state, and local organizations.

#### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Stanford University (Stanford) to develop an equitable, affordable, and resilient nationwide energy system transition (EARNEST) suite of tools to deliver to tribes, states, traditionally under-represented groups, and regions.

Award activities would include literature review, data and information gathering, data analysis, simulation, computer modeling, development of data tools, organization of workshops and events, undergraduate and graduate student education and training, seminars and webinars, paper studies, document preparation, peer-reviewed studies, surveys and expert elicitation studies, and analytical review.

Award activities will occur at a number of facilities including; Argonne National Lab (ANL), Pacific Northwest National Laboratory (PNNL), Lawrence Livermore National Laboratory (LLNL), Stanford University, Iowa State University, Massachusetts Institute of Technology, North Carolina Agriculture and Technical State University, Princeton University, Tec de Monterrey (Mexico), University of Alaska Fairbanks, University of Calgary (Canada), University of California San Diego, University of Hawaii at Manoa, University of Michigan, University of Tennessee, University of Texas, University of Waterloo (Canada), Electric Power Research Institute, NRECA, and Northwest Indian College.

Proposed activities would be limited to intellectual, academic, or analytical in nature therefore; no effects would be expected as a result of project activities.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

# FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

DOE has determined that work to be carried out outside of the United States, its territories and possessions is exempt from further review pursuant to Section 5.1.1 of the DOE Final Guidelines for Implementation of Executive Order 12114; "Environmental Effects Abroad of Major Federal Actions."

The proposed action is categorically excluded from further NEPA review.
