Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Iowa State University (ISU) to design, fabricate, and test bat deterrent aerodynamic whistles at both a laboratory-scale wind tunnel and a utility-scale wind turbine.

Award activities would focus on aerodynamic and aeroacoustics testing of deterrent whistles and field testing. Acoustic testing of active and passive whistle designs would be carried out by ISU (Ames, IA) and Virginia Polytechnic Institute (Blacksburg, VA), including amplitude, frequency, and flow speed testing and modulation. Field testing would be carried out on a Vestas V110-2.0 MW wind turbine at University of Minnesota's Eolos Wind Research Station (Eolos; Rosemount, MN), and would include the installation of acoustic deterrent whistles, microphones, weather protection equipment, and wind screens on the existing wind turbine at Eolos. Eolos is an existing wind turbine research station that regularly carries out research; thus, award activities are consistent with the current mission and operation of the facility.

Award activities would involve typical hazards associated with laboratory-scale wind tunnel and utility-scale wind tunnel operation. Existing university health and safety policies and procedures will be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
