Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to authorize the administration of a three-phase prize competition, known as the "Building Envelope Innovation Prize-Secondary Glazing Systems (SGS)". The prize would provide financial assistance toward the development and production of solutions for upgrading inefficient windows in buildings to enable building decarbonization retrofits and optimize building envelopes for building electrification. Finalists will secure equity-focused pilot(s) in low-income multifamily or underserved public sector buildings as a component of their commercialization plans.

This ND only covers the development of design concepts and prototype plans (Phases 1 and 2). Three prize winners would be selected in Phase 2. Phase 3 would include site installations and commercialization, which require additional NEPA review.

Finalists selected from Phase 2 would submit a technical and equity-focused pilot project narrative outlining their plans for successful integration of SGS. The submission for Phase 3 would be judged on sales volume, number of demonstrations, payback period for customers, and field demonstration that include energy performance metrics.

Prize competition activities of any applicant selected within Phases 1 and 2 would include only intellectual, academic, design, development, laboratory prototyping, and analytical activities. Laboratory prototyping activities are anticipated to occur within existing facilities and prototype testing would occur at approved testing laboratories. Based on the types of activities anticipated to occur as part Phases 1 and 2 of the prize competition, DOE does not anticipate any impacts to resources of concern.
