Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Siting, construction, modification, operation, and decommissioning of facilities for indoor small-scale research and development projects and small-scale pilot projects using nanoscale materials in accordance with applicable requirements (such as engineering, worker safety, procedural, and administrative regulations) necessary to ensure the containment of any hazardous materials. Construction and modification activities would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible).

## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the University of Hawai'i at Manoa (UHM) to develop a durable and low-cost membrane electrode assembly (MEA) for proton exchange membrane fuel cells (PEMFCs) for application in medium- and heavy-duty vehicles.

Award activities would include catalyst design and synthesis, catalyst characterization, creation of PEMFCs, development of MEAs, and evaluation of catalysts, membranes, and component interface. Catalyst synthesis and evaluation, as well as fabrication of MEAs would be conducted at the Hawai'i Natural Energy Institute (HNEI; Honolulu, HI) at UHM. University of California, Merced (Merced, CA) and Ionomr Innovations. Inc. (Rochester, NY; Vancouver, BC, Canada) would carry out design, characterization, fabrication and evaluation of catalyst ink, electrode layers, and MEAs. Colorado School of Mines (Golden, CO) would assist with catalyst, catalyst layer, and component interface characterizations.

Award activities would involve handling and use of hazardous materials, including gas, solvents, solid oxides, salts, solutions, acidic electrolytes, and nanoparticle substrates. Project activities involving hazardous materials pose no risk to the public. Hazardous materials would be utilized, managed, stored, and disposed of in accordance with applicable federal, state, and local environmental regulation. Nanoparticles are thermodynamically stable and physically bounded to substrates and would pose no risk to laboratory staff. Existing lab, and governmental health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

Proposed activities would occur entirely within existing research and development facilities that are purpose-built for the type and scale of activities being proposed. DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.

#### FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

DOE has determined that work to be carried out outside of the United States, its territories and possessions is exempt from further review pursuant to Section 5.1.1 of the DOE Final Guidelines for Implementation of Executive Order 12114; "Environmental Effects Abroad of Major Federal Actions."

The proposed action is categorically excluded from further NEPA review.
