Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to authorize the administration of a prize competition, known as the "Collegiate Wind Competition 2025," designed to provide opportunities for teams of university students to solve challenges associated with the wind energy industry. Participating teams would participate in four simultaneous contests, all of which would be completed over three phases. The competition would be completed in less than one year and cash prizes totaling up to \$280,000 would be awarded to participating teams. The competition would be administered by DOE and the National Renewable Energy Laboratory (NREL).

This NEPA Determination (ND) only applies to Phase 1 activities. Phase 1 activities would be limited to intellectual, academic, and analytical activities and only include the application phase of the competition. This ND does not apply to Phase 2 and Phase 3 activities. DOE will complete the NEPA review for Phases 2 and 3 when sufficient information is available to conduct a meaningful review. Sufficient information includes the finalization of Phase 2 and 3 rules.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
