

Proposed Action Title: Install 11.4 Tesla NMR Magnet in 735-A, Lab A-151

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Modify existing lab Instrument Air (IA) in Bldg. 735-A in Lab A-151, to serve new 11. 4 Tesla Bruker 500 NMR magnet. Mount wall-anchored compressed air components: 10L pressure vessel and N2 Scrubber. Install distribution manifold extension with four (4) valved outputs and regulators as required for magnet functions. Bruker (vendor) will: (1) de-energize existing magnet, (2) install connections to components (listed in this SOW) downstream of the manifold, and (3) complete contract requirements for and provide start-up operation of new magnet.
