Description:

A9 Information gathering, analysis, and dissemination

Rationale for determination:

The Department of Energy (DOE) is proposing to provide funding to the National Association of State Energy Officials (NASEO). Proposed efforts would include technical assistance to the State and Territory Energy Offices (hereinafter "State Energy Offices"), as well as provide communication and coordination assistance between DOE and the State Energy Offices on the implementation of DOE's State Energy Program (SEP). Efforts would be directed to activities supported under the Infrastructure Investment and Jobs Act (IIJA) and SEP annual formula funding.

Key NASEO activities would include facilitating a best practice exchange among State Energy Offices on clean energy planning and implementation through IIJA. Additional support would be provided with rapid-response technical assistance to address planning, implementation, and administrative needs of the states, with a focus on elevating challenges faced by the State Energy Offices. Strategic planning and implementation support on a multi-state basis to deliver efficient and coordinated energy program implementation would also be available. Lastly, NASEO would enhance state-federal collaboration with SEP annual formula funding and other IIJA-supported formula funding to help the State Energy Office's build capacity for program implementation by leveraging local expertise.

All activities in this award would be limited exclusively to intellectual, academic, or analytical activities. Based on the types of activities, DOE does not anticipate any impacts to resources of concern.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
