Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the City of Albany, California to develop and host community outreach and education events regarding energy efficiency, electric appliances, and gas line decommissioning. Additionally, several individual homes throughout the city would receive energy assessments and customized electrification recommendations.

Community outreach and education activities would involve the development of educational outreach materials and content, hosting outreach events, hiring consultants, conducting surveys, data analysis, reporting, and dissemination of information. The energy assessments would involve building audits, collecting data, recommending possible electrification options, theoretical project planning and pricing, and holding meetings. No physical modifications would occur to any structures as a result of award activities.

The City of Albany would observe all applicable federal, state, and local regulations and requirements. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.
