Proposed Action Title: 235-F Post Cold & Dark FY24

#### Proposed Action Description:

This EEC supports activities post Cold & Dark status of Building 235-F. This revision includes mechanical removal and disposition of ancillary equipment and facilities external to the 235-F FAMS (F-Area Material Storage) building that do not affect facility integrity and that will support future decommissioning of 235-F.

Rev. 3 summary: This revision includes mechanical and electrical isolation followed by removal and disposal of ancillary equipment and facilities external to the 235-F FAMS (F-Area Material Storage) building that do not affect facility integrity.

Rev. 4 summary: This revision includes the proposed activity of cutting various conduits to grade and then the grouting of them in Building 720-F and exterior of 235-F.

Rev. 5 summary: This revision includes mechanical and electrical isolation followed by removal and disposal of extant ancillary equipment and facilities external to the 235-F FAMS (F-Area Material Storage) building that do not affect facility integrity.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
