Description:

**A9 Information gathering, analysis, and dissemination**

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

**B3.6 Small-scale research and development, laboratory operations, and pilot projects**

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

**B3.15 Small-scale indoor research and development projects using nanoscale materials**

Siting, construction, modification, operation, and decommissioning of facilities for indoor small-scale research and development projects and small-scale pilot projects using nanoscale materials in accordance with applicable requirements (such as engineering, worker safety, procedural, and administrative regulations) necessary to ensure the containment of any hazardous materials. Construction and modification activities would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible).

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Colorado School of Mines (CSM) to fabricate, model, and characterize test structures to predict and reduce degradation defects in Gallium (Ga)-Doped Czochralski Silicon (Cz Si) solar cells. Project activities would include laboratory tests, data analysis, and modeling.

Proposed project activities that would occur at CSM (Golden, Colorado) include a sequence of experiments and characterization of Ga-doped Cz Si wafers using analytical tools. Computational work and modeling would occur at the University of Pennsylvania (Philadelphia, Pennsylvania). Experiments for sample fabrication and characterization would occur at the National Renewable Energy Laboratory (Golden, Colorado).

Potential hazards include the use and handling of pyrophoric gases as well as various acids, bases, and organic solvents used for cleaning and sample preparation. All hazardous materials would be managed in accordance with applicable federal, state, and local environmental regulations. Thin films of varying composition would be deposited directly on the wafers at the nanoscale level. However, these films are nontoxic and would remain attached to the substrate, thereby posing no risk related to the use of nanotechnology. Existing health, safety, and environmental policies and procedures would be followed at each facility, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

All project activities would be completed in existing, purpose-built facilities. No physical modifications to existing facilities, ground disturbance, or changes to the use, mission, or operations of existing facilities would be required. No additional permits or authorizations would be required.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or

stakeholders. Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

**FOR CATEGORICAL EXCLUSION DETERMINATIONS**

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
