Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to ExSorbtion Inc. to design, build and commission a brine feed skid-based fully integrated direct lithium extraction (DLE) unit. The DLE unit could be easily transported across multiple geothermal and oilfield sites and used to evaluate the unit economics of lithium production from those sites.

Award activities would be completed over two Budget Periods (BPs,) with a Go/No Go Decision Point between the BPs. BP1 activities would include lab-scale testing and validation, modeling, design, and fabrication of the skidded field demonstration DLE unit, equipment costing, techno-economic analysis, and selection of a field-testing location. BP2 activities would include lithium production in the field using the mobile DLE unit developed in BP1. Since the location(s) for field testing has not yet been identified, this NEPA determination applies only to BP1 activities. DOE will complete the NEPA review for BP2 activities when sufficient information is available to conduct a meaningful review.

All proposed project activities in BP1 would occur at ExSorbtion Inc.in Sunnyvale, CA.

Project activities would involve the use and handling of various hazardous materials, including acids and reagents. All such handling would occur in-lab, under proper hazardous material handling and disposal practices. Hazardous materials would be managed in accordance with federal, state, and local environmental regulations. Existing health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments. Emergency procedures are outlined in ExSorbtion Inc's Hazardous Materials Business Plan.

All project work would be performed at existing, purpose-built facilities. No modifications to existing facilities, ground disturbing activities, or changes to the use, mission, or operation of existing facilities would be required. No additional permits, licenses, or authorizations would be required. DOE does not anticipate any impacts to resources of concern due to the proposed award activities.
