Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

B5.1 (a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy Actions to efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such conserve as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and energy or water governments (such as state, local, and tribal). Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the National September 11 Memorial and Museum at the World Trade Center (Memorial) to retrofit light fixtures from the North and South Memorial pools with light emitting diodes (LED).

Project activities at each site would be as follows:

- 1. Memorial (New York, New York): Removal and reinstallation of light fixtures at Memorial pools.
- 2. Lighting Manufacturer (Winona, Minnesota): Retrofit original light fixtures with new LED strips.

The proposed project would involve the original light fixtures to be removed (one side at a time) from the Memorial pools and sent to the manufacturer, Acuity Brands Lighting, for retrofitting. The fixtures would be temporarily replaced with spare lights so the pools would remain functional during LED retrofit. There are 34 fixtures per pool side; a total of 272 fixtures would be retrofitted with LEDs.

There would be no new ground disturbing activities as work would be limited to the existing pools during the removal and replacement of the light fixtures and retrofitting would occur at the manufacturer's purpose-built facility. Light fixtures would be shipped to manufacturer and then back onsite. No change in the use, mission, or operation of existing facilities would arise out of this effort.

The project engineers would follow a detailed method of procedures to remove and reinstall the fixtures including but

not limited to de-energizing fixtures prior to work and use of proper personal protective equipment. No known hazardous materials would be brought into contact with the public.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
