Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to Fermi National Accelerator Laboratory (Fermi) for the installation of a photovoltaic (PV) and energy storage system at the Fermi National Accelerator Laboratory in Batavia, Illinois. These award activities would assist the Fermilab campus toward mitigating climate change impacts of site operations and improve the operating reliability of campus infrastructure to support the consistent operation of accelerator facilities.

This project would be implemented over two Budget Periods (BPs). BP1 would consist of issuing a Notice of Opportunity, selection of qualified Energy Service Companies, completion of a preliminary assessment and Investment Grade Audit, PV system design, and awarding of final contract. BP2 would consist of PV system installation, monitoring, and reporting. At this time, the final design and location of the PV system are unknown and there is insufficient information to review BP2 task 5 (subtasks 5.1 through 5.3). As such, this NEPA determination (ND) applies only to BP1 (all subtasks) and BP2 (subtask 6.1). An additional NEPA review would be required for activities listed under BP2 (subtasks 5.1 through 5.3).

Design and development activities would occur at the Fermi National Accelerator Laboratory in Batavia, Illinois. Project activities would involve administrative actions and analysis and would not result an any health or safety hazards.

All work would be performed at existing, purpose-built facilities. No modifications to existing facilities, ground disturbing activities, or changes to the use, mission, or operation of existing facilities would be required. No additional permits, licenses, or authorizations would be required.

Because Fermi is a federal facility, it is required to comply with the National Environmental Policy Act (NEPA) for this project. This would include completing an environmental review for the project, including any necessary consultations and geotechnical or other surveys prior to a decision whether to proceed. If Fermi proceeds with the proposed project after their NEPA review, they would be required to obtain all necessary permits and follow appropriate environmental, health, and safety measures. Fermi must provide its final NEPA determination(s) to their DOE Federal Energy Management Program (FEMP) Technical Project Officer or point of contact.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate

impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
