Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to WEI7 LLC (WEI7) to create a prototype rapid x-ray inspection system for the inspection of wind turbine blades. The x-ray system would be used to identify anomalies on wind turbine rotor blades and their components.

Award activities would include research and development, engineering, laboratory testing, and data analysis. Design, fabrication, and testing of the x-ray system would be carried out at WEI7 (Onalaska, TX). TPI Composite Blade Factory (TPI; Newton, IA) would carry out testing of the prototype x-ray blade inspection system fabricated at WEI7. Both WEI7 and TPI would fabricate composite test articles as needed. All project activities would be completed in existing, purpose-built facilities. No facility modifications, new permits, or licenses would be needed to perform project activities.

Potential hazards include handling of fiberglass, resins, and epoxy hardener, as well as potential exposure to ionizing radiation. All such handling would occur in laboratory settings. Award recipients would adhere to established health and safety policies and procedures when performing project work, including proper shielding from x-ray equipment, and would observe all applicable federal, state, and local health, safety, and environmental regulations.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
