Project Title: Road Repairs at the Bluewater, New Mexico, Disposal Site

Location: Bluewater, New Mexico

Proposed Action or Project Description:

LM is proposing to maintain and repair existing roads at the Bluewater, New Mexico, Disposal Site located approximately nine miles northwest of Grants in Cibola County. Proposed activities would include repairing eroded areas where the road crosses arroyos and where the road is inadequately graded to allow for improved drainage. The repairs are needed to maintain site accessibility and to prevent future road deterioration and erosion. Proposed road repairs would be in accordance with the Long-Term Surveillance Plan and in keeping with responsible land steward practices and commitments LM made to local stakeholders as well as to satisfy the goals of protecting human health and the environment and sustainably managing and optimizing the use of land and assets.
