Program or Field Office: U.S. Department of Energy (DOE) Office of Legacy Management (LM)

Project Title: Transportation of Evaporation Pond Water from the Rifle, Colorado, Disposal Site to the Grand Junction, Colorado, Disposal Site

Location: Rifle, Colorado, Disposal Site (Uranium Mill Tailings Radiation Control Act Title I)

Proposed Action or Project Description:

DOE-LM is proposing to remove and transport water from the Rifle Disposal Site evaporation pond to the Grand Junction Disposal Site (GJDS) decontamination evaporation pond to prevent leachate from breaching the top of the Rifle pond liner. This work is necessary to manage the leachate in the evaporation pond and prevent a manual shutdown of the current dewatering operations of the disposal cell. This proposed action would fulfill the general license requirements in Title 10 Code of Federal Regulations Section 40.27 (10 CFR 40.27) that identifies LM as the long-term custodian of the site and would be performed in a manner that protects human health and the environment.

- There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
- The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1501.9(e)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.1(g)(3)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized by the LM Director per DOE Policy 451.1), I have determined that the proposed action fits within the specified classes of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
