Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the NAESB Base Contract for Sale and Purchase of Natural Gas (as may have been amended from time to time, the "Base Contract") and the Transaction Confirmation ("Confirmation"), entered into by Sabine Pass on July 31, 2015 and April 16, 2024 (respectively) with Kaiser Marketing Appalachian LLC ("Counterparty"). Under the Base Contract and Confirmation, Counterparty will sell and Sabine Pass will purchase natural gas on a long-term basis. Sabine Pass intends to liquefy the natural gas purchased from Counterparty at the Sabine Pass LNG facilities.

Sabine Pass is also filing herewith a public summary of the major provisions of the Base Contract and Confirmation. Similarly, in respect of any day, the Buyer is obliged to take a specified quantity of gas, or compensate the Seller if not taken, unless otherwise excused under the contract.
