Proposed Action Title: Insertion of Mini-TCAP into Tritium Extraction Facility

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The modification of TEF systems to install Mini-TCAP isotope separation is explained in MT-TRI-2019-00010 Revision 0.

Mini-Thermal Cycling Absorption Process (TCAP) components are to be designed and installed into secondary confinement in TEF, and tied in to TEF Diffuser, Z-Bed Recovery (ZBR), Ventilation, Product Evacuation (P-EVAC), Mass Spec, and Flush Gas Evacuation systems.

Revision 1: Modified Detailed Description.

Revision 2: Revise activity end date and add project number.

Revision 2 of this EEC currently addresses the design and procurement portions of this modification. This EEC will be revised to include the facility modification portion of the work prior to construction and installation.

The proposal fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
