

Proposed Action Title: 211-8H Remove Women's Shower, Replumb for 4" Sewer Drain, Install a Toilet

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The 211-8H women's restroom is to be remodeled to remove the shower and the existing 2" shower drain line and replace it with a 4" drain line for a toilet to be installed in the same location. A 4" drain line is required for the toilet per the 2018 International Plumbing Code requirements.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
