Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the City of Shawnee for the design and installation of a 100-kilowatt solar photovoltaic (PV) system and associated components at its Fire Station 71. These activities would assist the City of Shawnee complete phase three of the State of Kansas Facility Conservation Improvement Program. System design and installation would be carried out by a qualified Energy Service Company. PV installation, data collection, and monitoring would occur at Fire Station 71 in Shawnee, Kansas.

All project activities would be completed in existing, purpose-built facilities. No facility modifications would be needed to perform project activities. Permitting would be completed by the City's Community Development Department. Potential hazards include safety risks related to construction activities. Existing city health, safety, and environmental policies and procedures would be followed, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.
