Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the University of California, Davis (UC Davis) to analyze, fabricate, and characterize test samples to mitigate performance degradation of silicon (Si) tunnel oxide passivated contact (TOPCon) solar cells. Project activities would include laboratory tests, data analysis, and modeling, as well as outreach presentations to nearby schools and groups.

Proposed project activities that would occur at UC Davis (Davis, California) include computational work and modeling. Experiments for TOPCon sample degradation, validation, and characterization would occur at the National Renewable Energy Laboratory (Golden, Colorado).

Potential hazards include the use and handling of pyrophoric gases as well as various acids and bases. All hazardous materials would be managed in accordance with applicable federal, state, and local environmental regulations. Existing health, safety, and environmental policies and procedures would be followed at each facility, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

All project activities would be completed in existing, purpose-built facilities. No physical modifications to existing facilities, ground disturbance, or changes to the use, mission, or operations of existing facilities would be required. No additional permits or authorizations would be required.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders. Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
