Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to GridBeyond LLC to develop an artificial intelligence (AI)-driven platform to forecast, optimize, and control megawatt-scale inverter-based renewable energy resources.

The proposed project consists primarily of analytical activities. Software development and computer modeling would be conducted by GridBeyond (Houston, TX) along with project partner New Mexico State University (Las Cruces, NM). GridBeyond would also partner with the Public Service of New Mexico (PNM) to demonstrate the provision of grid services using solar photovoltaic (PV) and Battery Energy Storage System (BESS) utilities at the Rio De Oro Solar Energy Center (Valencia Country, NM).

Implementation of control system software at the PNM facility would require new sensor and communication equipment on-site. The hardware would be installed indoors and would not involve any physical modifications or ground disturbance. Hardware-in-the-loop testing of the control system would be performed using existing equipment at the National Renewable Energy Laboratory (Golden, CO).

DOE has considered the scale, duration, and nature of the proposed project activities and does not anticipate any impacts to resources of concern. Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D.
