Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

Rationale for determination:

The U.S. Department of Energy's (DOE) Office of Energy Efficiency and Renewable Energy (EERE) is issuing the "Geothermal Resources' value in Implementing Decarbonization (GRID)" Funding Opportunity Announcement (DEFOA-0003346) to solicit applications from project teams focused on regional grid modeling studies that quantify the potential contribution of geothermal power to a decarbonized grid and economy. The GRID FOA addresses only one Topic Area. EERE anticipates making approximately 1-14 awards. Individual awards may vary between approximately \$500K and \$1.5M.

DOE has reviewed the FOA Requirements Document and determined that selected projects would be limited exclusively to intellectual, academic, or analytical activities. Desired project outcomes include reports on geothermal power representation in current integrated resource planning processes, best practice documentation, regional grid modeling study results, implementation of new metrics within grid modeling studies, and infographic materials for dissemination of project results. Applications that fall outside the technical parameters specified in the FOA would not be considered.

Based on the nature and scale of research solicited by the GRID FOA, DOE does not anticipate any impacts to resources of concern due to any future project activities. This NEPA Determination applies to the issuance of DE-FOA-0003346 as well as all awards selected under the FOA, provided the scope of the selected awards remains consistent with the intent of the FOA as currently described. If selected applicants propose to use project funds for activities outside the scope of this NEPA Determination, additional NEPA review will be required.

NEPA PROVISION

DOE has made a final NEPA determination.

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
